To be eligible to receive a 19+ Bursary in the 2020/21 academic year, you must be aged 19 or over.

To Apply

All applications will be assessed on an individual basis.

We recommend that you apply early as funds are limited and demand is always high. You can apply on the College's online secure portal 'Pay My Student'. You will need to register for an account and will need to know your student number (this is on your Student ID badge). Please log on to: <https://nelson.paymystudent.com>

20+ Child Care

Learners aged 20 or over can apply for a bursary* where they are at risk of not starting learning or not continuing learning as a result of child care costs. The allocation of funds is purely on a "first-come, first-served" basis.

Please note continuing and progressing learners need to apply each academic year – there is no automatic carry forward of any award given.

To be eligible for funding from the 20+ Child Care Learner Support Fund, learners should have an annual household income below £31,000 and/or be in receipt of one or more of the following benefits:

- Income Support
- Income-based Job Seekers Allowance
- Employment and Support Allowance (ESA)
- Child Tax Credit and have an annual gross income
- Working Tax Credit
- Universal Credit to replace any of the above benefits

If you are 19 you can apply to Care 2 Learn for help with child care costs. Please speak to the Student Services team for more information.

Bursaries

Bursaries are awarded on a case by case basis and are dependent on individual circumstances. Support available may include travel, bus passes, food, books, uniform and equipment.

To be eligible for a bursary you must have a household income below £31,000 and/or be in receipt of one or more of the following benefits:

- Income Support
- Income-based Jobseekers Allowance
- Employment and Support Allowance (ESA)
- Working Tax Credit with an annual gross income of no more than £31,000
- Child Tax Credit and have an annual gross income of no more than £31,000 as assessed by Her Majesty's Revenue & Customs
- Universal Credit to replace any of the above benefits.

Advanced Learner Loan Bursary

If you have paid for your course with an Advanced Learner Loan and your household income is under £31,000 then you may be eligible to apply for financial assistance from the Advanced Learner Loan Bursary.

Discretionary Bursaries

Discretionary bursaries* are awarded on a case by case basis and are dependent on individual circumstances. Support available may include travel, bus passes, food, books, uniform and equipment.

Where your household income is over £31,000 and you have dependent children/adults, additional financial support may be available. Special circumstances will be considered on a case by case basis.

Travel Passes

If you are aged 19 or over with a household income of less than £31,000 you can apply for a FREE* or subsidised* travel pass.
